

The stereotypical family image – mother, father and two children – is now a myth. Today's census¹ confirms that a great proportion of the UK's households² now comprise single parents, adult children living with their parents, or pensioners. Much of the data we can find in the census confirm well-established underlying³ trends.

Apart from the erosion of the nuclear family the main

- d the development of extended families: networks of stepparents, stepchildren, cousins, aunts, uncles and grandparents. This group reflects changing demographics due to increased rates of divorce and remarriage;
- young people tend to live at home: 58% of men and 39% of women aged 20-24 in England still live at home with their parents;
- there are large numbers of single people living in London; married couples and families are mainly in the centre of the country and around the outskirts⁴ of major cities;
- g the number of people in England and Wales living with or married to someone from another ethnic group is growing.

1 census: an official process of counting a country's population and finding out about the people.2 household: all the people who live together in one house.

3 underlying: the most important even if not easily noticed. **4 outskirts**: the parts of a town or a city that are furthest from the centre.
